
UPON THE APPLICATION by Hudson & Company Insolvency Trustees Inc., in its capacity as the Court-appointed receiver (the "**Receiver**") of the assets, undertakings, and properties of Petrocapita Oil and Gas L.P., Petrocapita G.P. I Ltd., Petrocapita Processing L.P. and Petrocapita GP II Ltd. (collectively, the "**Debtors**"); AND UPON reading the Third Report of the Receiver (the "**Third Report**"), filed, and Confidential Appendix 1 to the Third Report of the Receiver, unfilled (the "**Confidential Supplement**"); AND UPON hearing submissions of counsel to the Receiver;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, and no other person is required to have been served with notice of this application, and time for service of this application is abridged to that actually given.
2. The requirement of the Receiver, as applicant, to serve a Notice to Media of Application to Restrict Access, is waived and dispensed with.
3. Part 6 Division 4 of the *Alberta Rules of Court*, Alta Reg 124/2010 does not apply to this application.
