

**TRUSTEE'S REPORT ON PRELIMINARY ADMINISTRATION**

**IN THE MATTER OF THE BANKRUPTCY OF**

**GENESIS TECHNICAL SYSTEMS CORP.**

**BKY 25-2955007**

**HUDSON & COMPANY INSOLVENCY TRUSTEES INC.**

Genesis Technical Systems Corp. (hereinafter referred to as “**Genesis**” or the “**Company**”) filed a voluntary assignment into bankruptcy pursuant to Section 49(1) of the *Bankruptcy and Insolvency Act* (“**BIA**”) on June 14, 2023 with Hudson & Company Insolvency Trustees Inc. appointed as Licensed Insolvency Trustee (“**Trustee**”).

Genesis operated as the Canadian intermediary for a related entity known as Genesis Technical Systems UK Ltd (“**Genesis UK**”). Genesis served as a conduit for the investment process, as it allowed for pooling of funds from Canadian investors and such funds were subsequently transmitted to Genesis UK. Prior to the assignment of Genesis it is understood that Genesis UK was assigned a liquidator as it was insolvent.

SECTION A - The Trustee's duties under Section 16(3) of the *Bankruptcy and Insolvency Act*:

Class I - Stocks and Merchandise:

- The Company’s inventory consisted of various patents and was valued on the Statement of Affairs at \$1.00. It is anticipated the Trustee will not pursue the realization of the various patents as there are insufficient funds in the estate to cover cost. However, creditors may choose to act pursuant to Section 38 (1) of the BIA, by either funding the Trustee to take action or, taking the action in their own name, at their own expense and risk, to realize on the patents.

Class II - Machinery and Equipment:

- The Company owned no machinery or equipment.

Class III - Buildings and Real Estate:

- The Company did not own buildings or real estate.

Class IV - Books and Records:

- The Trustee took possession of the electronic records of Genesis.

Class V - Other Assets:

- Genesis owned no other assets.

SECTION B - Conservatory and Protective Measures:

- None that the Trustee is aware of at this time.

SECTION C - Legal Proceedings:

- None that the Trustee is aware of at this time.

SECTION D - Provable Claims:

- At the time of preparing this report, there have been several unsecured claims filed in the bankruptcy proceedings. A detailed claims register is attached to this report as Exhibit "A".

SECTION E - Secured Claims:

- Based on the Trustee's review of the Company's Personal Property Registry, it appears that there are no secured creditors in this proceeding.

SECTION F - Priority Claims:

- None that the Trustee is aware of.

SECTION G - Reviewable Transactions and Preference Payments:

- None that the Trustee is aware of.

SECTION H - Other Matters:

- A third party deposit in the amount of \$14,959.00 has been obtained to guarantee the costs of the administration of the Trustee.
- The management of Genesis informed the Trustee that the computer equipment owned by the Company was donated. As per the Company, the items were old and outdated and would therefore have a nominal value in the bankruptcy.

SECTION I - Realization:

- The Trustee does not anticipate any distribution to unsecured creditors.
